This warranty applies to fence systems constructed entirely of components manufactured and/or supplied by Master Diamond.

Damage from abnormal or improper use or design, accident, alteration, neglect, abuse, abrasion, air pollutants, improper service or installation, or damage caused by flood, fire or act of God is not covered by this limited warranty. Use in harsh industrial, coastal or marine environments is not warranted.

To protect your rights under this warranty, please register your product online and return a copy of your store receipt to Master Diamond within 30 days of purchase. Warranty coverage is not conditional upon the return of your receipt provided you can furnish proof that the SPECTRA® Color Chain-Link Fence System was supplied by Master Diamond and meets all of the requirements. A completed registration form and copy of store receipt is your best proof of coverage under this limited warranty.
